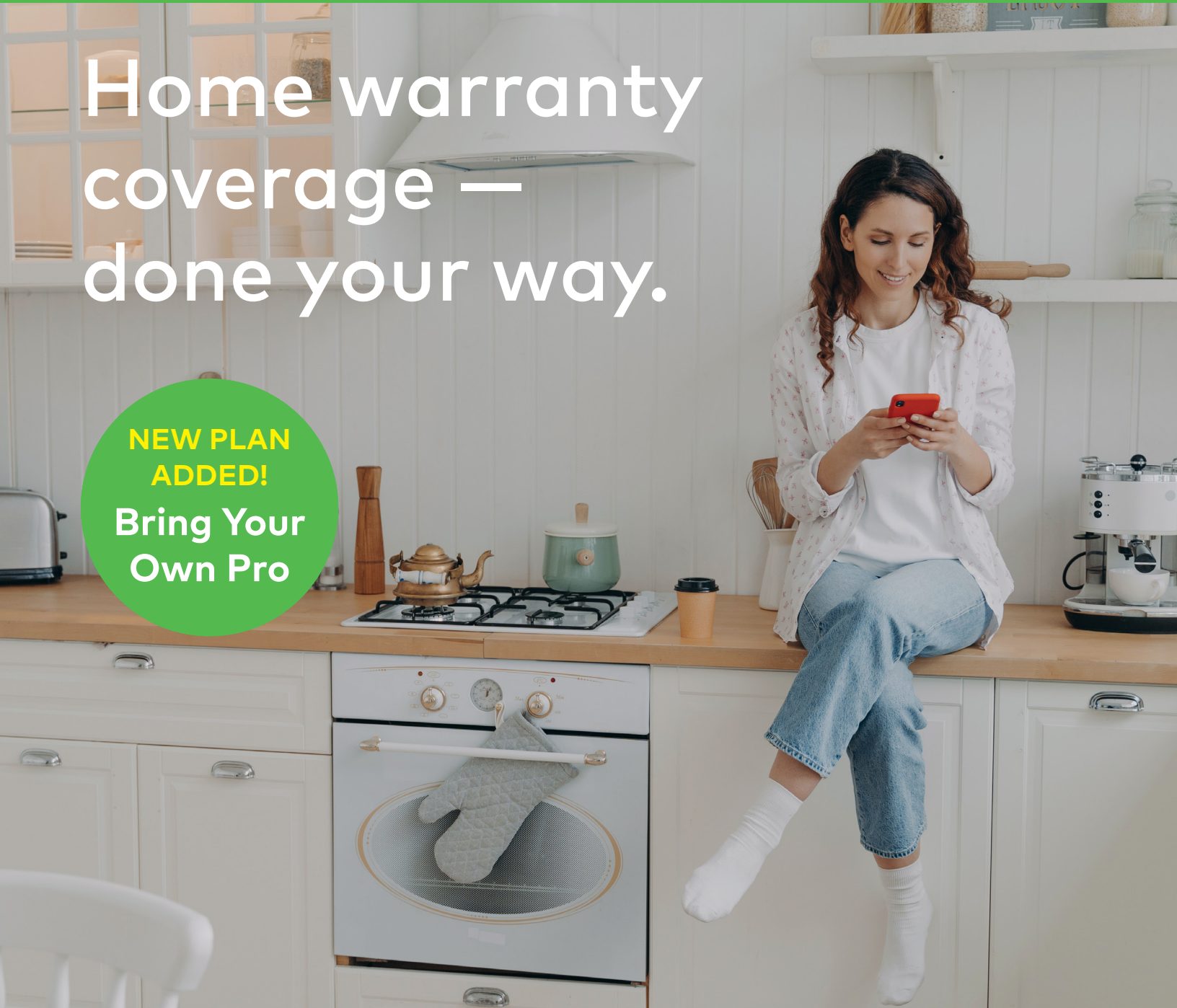

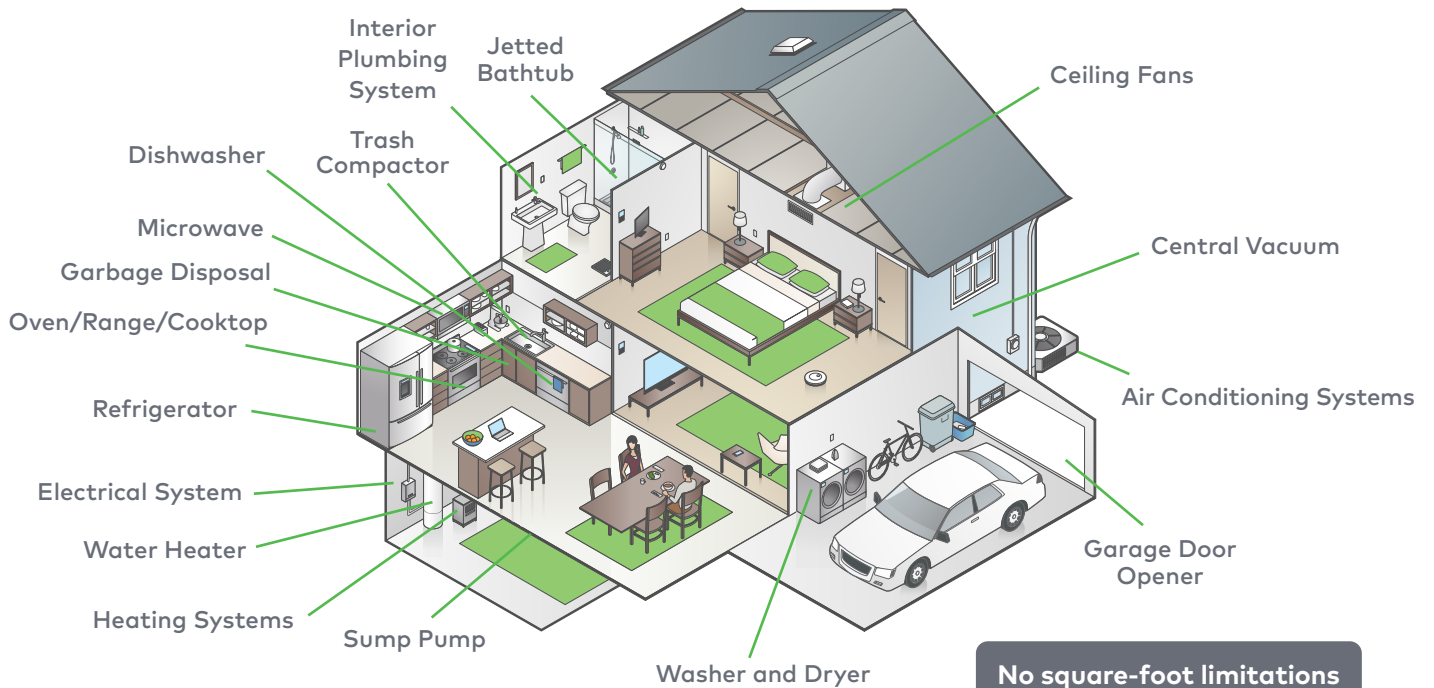

Bring Your Own Pro

When a breakdown happens,
follow these three simple steps:



1

Start request

Call us to confirm that the item needing service is covered. We'll go over the next steps, and then you can schedule the licensed service pro of your choice to diagnose the issue.



2

Get approval

Call us back with the diagnosis before your service pro does any work. We'll verify coverage and the amount we'll pay. Then you can proceed with the repair.



3

Get payment

Once the repair is complete, call us back, and we'll gather the info needed to pay the covered portion. You are responsible for paying a \$100 deductible and any amounts we do not cover.
